CHAPTER INCENTIVES & CONTRIBUTIONS

INCENTIVES

- \$5 HOME RUN**
To any member that has at least four (4) outside tips at a meeting and a pin and badge must be worn.
- \$10 TIPPING THE SPEAKER**
Any qualified tip to the speaker, during the week and up to end of the next meeting will result in a \$10 incentive.
- \$25 FIVER DAY GUEST**
Members that bring a qualified guest to a fiver day meeting receive \$25 per guest.
- \$25 QUALIFIED GUEST COMES TO A MEETING**
Remind the guest to be on time (7:00am) and bring 50 business cards. If the guest or member arrives after 7:00am or leaves early, no incentive is paid.
- \$30 GRAND SLAM**
To any white badge member that has at least four (4) outside tips, wearing a pin and badge and at least one (1) qualified guest. Member and guest must arrive by 7:00am.
- \$25 to \$100 NON-TIPPED MEMBERS INCENTIVES**
Any member that tips a non-tipped member will receive a \$25 incentive per month, for up to four (4) months (\$100). The tip must have a monetary value equal to the amount of the incentive.
- \$100 BEN FRANKLIN INCENTIVE**
Any member that has their badge turn BLUE (3rd recruited member) will receive a \$100 incentive.
- 1 QUARTER DUES PAID QUALIFIED GUEST JOINS THE CHAPTER**
The member that successfully recruits a member will have one quarter of dues paid.
(The new member must remain in the chapter for one (1) full quarter, prior to the incentive being paid).

- \$10 DELINQUENT ON CHAPTER DUES (FOR EACH WEEK LATE)**
- \$20 CELL PHONE RINGING DURING MEETING**
- \$25 FAILURE TO SPEAK (WITH NO REPLACEMENT SCHEDULED)**
- \$25 NO QUALIFIED GUEST FOR BUSINESS MIXER**
- \$25 ABSENT FROM BUSINESS MIXER**
- \$35 ABSENT FROM CONFIRMED NETWORK TRAINING SEMINAR**
